Procedure

Annually by July 1, Cameron University produces a report containing the following information for the most recent year that data is available:

- The six-year graduation rate, categorized by race and gender, for first-time, full-time baccalaureate degree seeking students.
- The average over the last four years of the six-year graduation rate, categorized by race and gender, for first-time, full-time baccalaureate degree seeking students.
- The six-year graduation rate, categorized by race and gender, for all student athletes.
- The average over the last four years of the six-year graduation rate, categorized by race and gender, for all student athletes.
- The student athlete Academic Success Rate, categorized by race and gender, for all student athletes.
- Full-time baccalaureate degree seeking undergraduate enrollment for the previous Fall semester, categorized by race and gender.
- Student Athlete enrollment for the previous Fall semester, categorized by race and gender.
- The number of student athletes who received athletically-related student aid for the previous Fall semester, categorized by race and gender and sport (basketball, football, baseball, cross-country and track combined, and all other sports combined).
- The six-year graduation rate for entering students who received athletically-related student aid, categorized by race and gender within each sport (basketball, football, baseball, cross-country and track combined, and all other sports combined).
- The average over the last four years of the six-year graduation rate for entering students who received athletically-related student aid, categorized by race and gender within each sport (basketball, football, baseball, cross-country and track combined, and all other sports combined).
- The student athlete Academic Success Rate for entering students who received athletically-related student aid, categorized by race and gender within each sport (basketball, football, baseball, cross-country and track combined, and all other sports combined).

Rates for student athletes are completed and submitted to the Department together with other Student-Right-to-Know data by the Graduation Rates Survey deadline.
